Sir,

In producing herewith one seized fire arms with body, barrel and trigger along with 01(one) .303 round of ammunition seized from the dwelling house of police remand accused Sudipto Roy Chowdhury(45) S/O Lt. Aditya Roy Chowdhury of vill- Shyampur, Anara, P.S- Para, Dist - Purulia as shown and identified by him. I SI Supratik Mondal of Adra P.S hereby lodge a complaint against the above noted accd. person to the effect that on 14/12/18 I took up investigation of Adra P.S Case No. 103/18 dtd. 14/12/18 u/s 341/302/120 B IPC and 25/27/35 Arms Act. In that case, the complainant Raju Ansary alleged that on 14/12/18 at about 10.50 hrs his brother Hamid Ansary was murdered by some unknown miscreants from gunshot injury near Misirdih Railway Level Crossing at Misirdih village, P.S- Adra, Dist.-Purulia.


In course of investigation, I arrested the above noted accd. person Sudipto Roy Chowdhury. I interrogated him and after interrogation he confessed his guilt stating that he along with other accd. persons committed the murder after gunshot injury. In this he used one improvised pipe gun along with others. In persuasion, I further inquired his statement and there was reason to believe that he has possessed and used fire arms.


On 28/12/18 at 18.35 hrs, myself along with force and the police remand accd. Sudipto Roy Chowdhury left for the dwelling house of the said accd. at vill- Shyampur, Anara, P.S- Para, Dist- Purulia. After a while, with the assistance of Anara O.P, we reached his house. After taking entry in presence of his family members we looked for the arms and ammunition. It is to note here that all the Police personnel were wearing proper uniform and we disclosed our identity. The accd. brought a plastic from his store room of his dwelling house and produced before us. On our request he opened the plastic packet and found one pipe gun and one .303 round ammunition. He claimed that in course of committing the murder of Hamid Ansary on 14.12.18 morning, he possessed the fire arms and ammunition. On questioning he failed to produce any valid document against the possessed fire arms and ammunition. Rather he confessed that he possesses the same illegally. I seized the arms and the ammunition as per seizure list. The fire arms is a country made improvised pipe gun and one .303 mm live cartridge. I summoned some of the local villagers before seizure. Neither they nor the family members signed the seizure list as witness. I also labeled the alamsats in the spot. A copy of seizure list is handed over to the accd.

The accd. Sudipto Roy Chowdhury possessed the arms illegally and he used the same in course of committing the murder. As such he is liable for offence punishable u/s 25Arms Act. It is a fact that the deceased Hamid Ansary was murdered with gunshot injury and the accd persons used fire arms for this purpose. On returning to Adra P.S, I am submitting this complaint against Sudipto Roy Chowdhury(45) S/O Lt. Aditya Roy Chowdhury of vill- Shyampur, Anara, P.S- Para, Dist- Purulia to start a and to arrange for its investigation.
