## Respected Sir,

In producing herewith one accused person namely Arun Kumar Muchi (30) S/O- Bhola Muchi of Parbelia Amdhowra, PS- Neturia, Dist- Purulia with seizure of (1) 23 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which was seized under proper seizure list.

I beg to submit that today (29.12.18) in between 20.05 hrs to 20.55 hrs. a raid was conducted at Parbelia Amdhowra village in the shop of Arun Kumar Muchi (30) S/O- Bhola Muchi of Parbelia Amdhowra, PS- Neturia, Dist- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Arun Kumar Muchi failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 23 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which was seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Arun Kumar Muchi (30) S/O- Bhola Muchi of Parbelia Amdhowra, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/1001 Soumendu Das, 2. C/470 Somnath Nag and 3. C/1260 Santosh Soren all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Arun Kumar Muchi (30) S/O- Bhola Muchi of Parbelia Amdhowra, PS-Neturia, District- Purulia under proper section of law.
