I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Santiram Mahato S/O Lt. Baju Mahato of Vill - Uchali, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 28.12.2018 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr.SAE(E), Sri Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Uchali under Purulia(M) P.S. When our team at about 03.00 P.M. entered to the Domestic premises of Santiram Mahato, we found that he was enjoying electricity dishonestly by means of Meter bypass by tampering service cable and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, Service cable with bypass arrangement dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 03.30 P.M. after completion of inspection & necessary formalities.

Santiram Mahato S/O Lt. Baju Mahato of Vill - Uchali, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
