Entered the premises of Animesh chowdhury, s.o- Mahadeb chowdhury of Village- Chakalta, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by bypassing from incoming service cable before energy meter.

Supply i.e. U/S 135 was detected.
