



The above named complainant;

Most respectfully begs to state :-

1...That the complainant's husband namely Ananta Mahato of Khukramura was a Railway employee died during his service life.

2... That the complainant being the wife and nominee of her husband have got paper of death benefit, P.F. and other payable amount and whe got account payee cheques.

3... That the accused No. 1 Bhim Mahato being a resident of same village and was aware of the facts about getting death benefits of the complainant.

4... That the accused No. 1 along with accused No. 2
Asit Mahato and accused No. 3 Milan Banerjee came to
the house of the complainant on 20.3.2018 at 5-30 P.M.
and demanded cheques for encashment with treating to
which the complainant refused to give her cheques to the
accused persons to which they became angried.

5... That thereafter the accused threatended the complainant by showing arms, daggar, to finish her if the cheques are not handed over to them.

6... That the complainant on the fear of the miscreants and for saving her life handed over the said 2 (two) cheq -ques to the accused persons on 20.3.2018 at 5-30 P.M. at her house at village Khukramura. The accd. also

The accd. also snatched away the valuable papers issued by Railway Department to her.

7....That the complainant on the same day 20.3.18 immediately lodged F.I.R. to the Police of Arsha P.S. against the all 3 accused persons, when Police assured her to recover the cheques and to take legal action against the accused persons but Police was not taking action when the complainant lodged the complainant against the accused persons before S.P. Purulia on 5.11.18 but till date no action has been taken against the accused persons hence this complain.

Under the aforesaid circumstances it is clear that all accused persons have committed criminal offences and accordingly they should be punished as per law.

Hence it is prayed that your Honour would be pleased to send this petition of complain to the O/C Arsha P.S. for investigation U/S 156(3) Cr.P.C. treating this as F.I.R.
