Entered the premises of Jalaluddin Ansary @ Galauddin Ansary Vill. Herodih (Near primary school)
P.S. Arsha Dist- Purulia, having Consumer No. 242055504 Meter No. 04217065
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan (80W) - 06 nos.
- 2) Freeze (120W) - 01 no.
- 3) Color TV (100W) - 02 nos.
- 4) Electric Bulb (100W) - 02 nos. 5) CFL - 04 nos.

Out of which I seized the following.

- 1) PVC 2 core cable with by-passing wire 10 ft' (APPROX).
- 2) Bulb with Holder - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 2:00 PM on 03/01/2019. The accused person has committed an offence U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
