In producing here with one arrested accd namely Paresh Mandi (42) S/O Lt. Lurka Mandi of Vill-Kultard P.S.-Arsha Dist-Purulia along with following seized articles viz -

1) one red colour plastic container with approx 15 ltrs of cholai,

2) one white colour plastic container with approx 5 ltrs of cholai,.

(Approx 500 ml taken out from the above containers as sample packed with sealing wax)

3) 5 (Five) bottle (in sealed condition) Dil Se country spirit, 375-ml each bottle and Rs-22/- of each bottle.

(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax.

4) 6 empty bottle of do in one plastic bag

I, SI Sanjoy Digar of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 06.01.19 at about 18:35 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling liquor illegally and clandestinely at Senabona more under Arsha PS, Dist- Purulia .On receiving the reliable source information I communicated with O/C Arsha PS over phone and as per his instruction I along with ASI Ujjal Rajak of Arsha PS, C/688 SK Sahid, C/985 Lakhindar Tudu, both of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. Reaching at Senabona we fixed-up the house of above noted accd. person and noticed that the selling country spirit was going on there and getting seen of police all customers were managed to escape, but we able to apprehended the above noted accused person. On demand he failed to produce any valid documents in support of selling country spirit. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused persons and witnesses among which one bottle of country spirit and 500 ML of Cholai were kept as sample file with label. During interrogation he confessed his guilty so, I arrested him after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act,1909.

I therefore pray that a specific case may kindly be started against the accused namely Paresh Mandi (42) S/O Lt. Lurka Mandi of Vill- Kultard P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act, 1909, and arrange it's regular investigation.
