Sir,

In producing here with one arrested accd namely Narayan Gorat (30Y) S/O- Gondhu Gorat of Vill- Harbaha P.S.-Kotshila Dist-Purulia along with following seized articles viz -

- 1) one motor Cycle ( Hero Honda Spender Plus) Bearing no -JH-09-H-3507 ,
- 2) Approx 40 ltrs of cholai in a black colour plastic container , mark as Exhibits -A which was carrying from said Motor Cycle , .
- 3) Approx 500 ml Cholai taken out from the above containers as sample packed with sealing wax mark as Exhibits -A-1

I ,SI Gokul Ch. Ruhidas of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today on 07.01.19 at about 11:05 hrs I along with C/970 Kartik Jana, C/914 Goutam Kumar Bag, both of SAP 7th Bn camp at Arsha PS left for day mobile duty vide Arsha P.S C.C no-67 /18 dtd 07.01.18 & Arsha PS GDE no 247 dtd 07.01.18. At about 14.15 Hrs when we are near Gugui more under Arsha P.S. on Tamna to Begunkodar pitch road, we found one person is going towards Arsha with a black colour big plastic container through motor cycle. Seeing us to proceed towards him, the person tried to flee away. Somehow we managed to intercept him & found approx 40 liters of colorless liquid smelling like cholai inside the container. On asking I confirmed that the liquid is cholai & he disclosed his name as mentioned above. I also inform that he will transport this Cholai spirit to other village. He failed to produce any valid document to posses & transport cholai spirit. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which one bottle (500 ML) of Cholai were kept as sample file with label. During interrogation he confessed his guilty. So, I arrested him after observing all the formalities issuing memo of arrest as the accused person is liable for prosecution u/s 46A(c) of The Bengal Excise Act, 1909.

I therefore pray that a specific case may kindly be started against the accused namely Narayan Gorat (30Y) S/O- Gondhu Gorat of Vill- Harbaha P.S.-Kotshila Dist-Purulia U/S 46A(c) The Bengal Excise Act,1909, and arrange it's regular investigation.
