I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Juru Kalindi, S/O- Lt Jugal Kalindi of village & PO - Pathardi, P.S- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 07/01/2019 at about 11:30 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Sukhamoy Maji, SAE (E) 2. Abdul Hasib, LM, entered the premises of Sri Juru Kalindi, S/O- Lt Jugal Kalindi of village & PO - Pathardi, P.S- Bagmundi, Dist- Purulia and found Sri Juru Kalindi was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Juru Kalindi S/O- Lt Jugal Kalindi committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji, SAE (E) 2. Abdul Hasib, LM. The inspection team left the premises at 11:40 a.m.
