On 07/01/2019 at about 11:45 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sukhamoy Maji, SAE (E) 2. Abdul Hasib, LM, entered the premises of Sri Balaram Kalindi, S/O- Lt Niranjan Kalindi of village & PO - Pathardi, P.S- Bagmundi, Dist- Purulia and found Sri Balaram Kalindi was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Balaram Kalindi S/O- Lt Niranjan Kalindi committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji, SAE (E) 2. Abdul Hasib, LM. The inspection team left the premises at 11:55 a.m.
