I do hereby lodge complaint empowered by enabling The Electricity Act - 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Sambhu Nath Muemu, S/o Mandhan Muemu of Village Barakadam was enjoying electricity unauthorily by means of direct hooking from nearest Low Tension Overhead Line and caused Revenue loss of WBSEDCL.

Has committed theft of electricity U/S 135(1)(a) of The Electricity Act 2007.

During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of WBSEDCL e.i. u/s 135(1)(a) was detected.
