In producing here with the arrested accused persons namely- 1. Bipin Mahato @ Bullet (24) S/O Dharmarai Mahato and 2. Dwijapada Mahato (45) S/O Lt. Balaram Mahato both are of vill- Darda; PS- PS-Jhalda; Dist-Purulia, along with seized articles- (i) Ten (10) pieces detonators, (ii) Ten (10) pieces POWERGEL 901 (Explosive 25mm X 125 g), (iii) Two (02) pieces wire (Black colour wire length approx 70 ft & Green colour wire length approx 60 ft), (iv) Eight (08) pieces hand made Bombs, (v) Two (02) plastic bags, I beg to lodge complaint to the effect that today i.e. 01.01.19 at about 18:05 hrs I received credible source information that above noted two persons are keeping hand made bombs & explosive substances illegally secretly at the backside of Darda village near a well with bad intention. Accordingly, I noted the fact in G.D. and left P.S. with vehicle (WB55/6183) to work out the said source information with A.S.I. Sk. Habibul Hasan, C/682 Mahadeb Rajak, C/1179 Pabitra Mondal, C/1376 Tapan Das, after obtaining kind permission from I/C Jhalda P.S. This refers to Jhalda P.S. GDE No. 23 Dtd: 01.01.19.

Then, I along with accompanied officer and force apprehended both the above noted arrested accused persons from the said place as mentioned earlier and disclosed our identity. Accordingly, I interrogate them thoroughly where they disclosed their identity as- 1. Bipin Mahato @ Bullet (24) S/O Dharmaraj Mahato and 2. Dwijapada Mahato (45) S/O Lt. Balaram Mahato both are of vill- Darda; PS- PS-Jhalda; Dist-Purulia. On search, we recovered and seized the following articles from their possession after preparing proper seizure list & Labels duly signed by

- (ii) Ten (10) pieces POWERGEL 901 (Explosive 25mm X125 g),
- (iii) Two (02) pieces wire (Black colour wire length approx 70 ft & Green colour wire length approx 60 ft),

During interrogation, they stated that one Bhogtu Gope of vill. Sikhartanr, P.S. Kotshila, Dist. Purulia had supplied all the above noted seized articles. They further stated that Bhogtu Gope had made the bombs with other unknown persons. Accordingly, I arrest them after prepare proper arrest memo.

Hike to note here that Ten (10) pieces detonators, Ten (10) pieces POWERGEL 901 (Explosive 25mm X 125 g), Two (02) pieces wire (Black colour wire length approx 70 ft & Green colour wire length approx 60 ft), were kept into a plastic bag and Eight (08) pieces hand made Bombs were kept into a another plastic bag concealing in a wet place of nearby well. During seizure, I put all the bombs into the water of a bucket with the help of Bamboo stick & net

Hence, I do here by lodged suomoto complaint against the following accused persons namely -

- 2. Dwijapada Mahato (45) S/O Lt. Balaram Mahato both are of vill- Darda; PS- PS-Jhalda; Dist-Purulia,
- 3. Bhogtu Gope of vill. Sikhartanr, P.S. Kotshila, Dist. Purulia and unknown miscreants to start a cog case against them as they are liable to punish U/S- 4/5 Explosive Substances Act, 1908 and arrange for its investigation.
