Entered the premises of **Samir Rajak (Present User)** , **S/o- Ratan Rajak** Vill- Hensahatu, PS- Jhalda, Dist- Purulia. having consumer Id- 242279626, Meter no 151451 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)/(B) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 04 nos.
2. Color T.V- 01 no.
3. Electric Fan – 01no.
4. Refrigerator - 01 no.
5. Stand Fan- 01 no.

Out of which I seized the following.

1. Two core service cables fitted with tapping cable approx length 5 ft.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 03.15 P.M on 03.01.2019. The accused person has committed an offence U/S 135(I)/(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007.
