Sir,

In producing herewith one arrested accused person namely Manoj Chowdhury (35) S/o- Babulal Chowdhury of Vill-Bhatbigha, PO-Kendua, PS-Sirdala, Dist-Nawada, State-Bihar A/P near Namopara Kabarsthan Joypur, PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. approx 18 Liters (eighteen) Illicit Distilled Liquor in 01 (one) white colour Plastic Jerrican under proper seizure with label.

I SI Jayanta Kr. Chakarboroty of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (06/01/2019) at about 20:45 hrs I received a credible source information that one person namely Manoj Chowdhury of Bihar State is selling ID liquor at Namopara near to Kabarsthan on Joypur -Hargara Road in their Jhupri. On receipt such information I immediately inform the matter to IC Joypur PS and as per his kind direction myself along with C/120 Sandip Kumar, RJC/1406 Iswar Singh Babu & JLC/1129 Sangita Banerjee (This refers to Joypur PS CC No. 81 dated 06/01/2019) left to work out the information from Dumurdih Naka Point. At 21:05 hrs we reached at the above noted place and entered in the house (Jhupri) of the above noted accused person as shown my source and found on seeing police party 02/03 persons, who were coming for consuming liquor, immediately fled away from there. I searched his house (Jhupri) and found 01 (one) white colour Plastic Jerrican loaded with Illicit Distilled Liquor kept in a corner of his house in concealed condition. I asked him about the license / authority of the said liquor, but he failed to produce any documents in respect of said Liquor. On interrogation he also made incoherent statement regarding possession of said liquor and told that that he is selling the same to the villagers illegally. So, finding no any other alternative way I arrested him from his Jhupri at 21:15 hrs after observing all the formalities as per law and narrating him the ground of arrest and issuing arrest memo. After that I seized the above noted articles from the possession of the accused persons and labeled, duly signed by the accused person & witnesses in between 21:20 hrs to 21:30 hrs in which I have taken one bottle of ID liquor i.e. one 300 ML as sample file with label. During interrogation he confessed his guilt as such I arrested him as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Manoj Chowdhury (35) S/o- Babulal Chowdhury of Vill-Bhatbigha, PO-Kendua, PS-Sirdala, Dist-Nawada, State-Bihar A/P near Namopara Kabarsthan Joypur, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909
