I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Fiya Pathak ,SAE(E),Joypur CCC 02.Ganesh Mahato,Gr1 TSH,Joypur CCC, entered the premises of Ramdas Bagdi, S/O-Paban Bagdi of village-Joypur Bagdi Para P.S- Joypur, Dist- Purulia and found Ramdas Bagdi, S/O-Paban Bagdi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSIEDCL through CU cable yellow colour by means direct hooking to his house premises and connected load found 0.06 KW. As Ramdas Bagdi, S/O-Paban Bagdi committed theft of electric power. The inspection team left the premises at 2.15 P.M.
