Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Asit Baran Acharjee S/O LT.Anil Baran Acharjee Vill-Chitra, PO- Agardi Dist-Purulia has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 07.01.2019 I received a secret complain over telephone that Sri Asit Baran Acharjee S/O LT.Anil Baran Acharjee Vill-Chitra, PO- - Agardi Dist-Purulia consuming electricity for his bricks farm at by means of hooking from nearest LT network of WBSEDCL.

On the basis of said complaint at about 1.30 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 2) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Asit baran Acharjee S/O LT.Anil Baran Acharjee Vill-Chitra, PO- - Agardi Dist-Purulia and found that Sri Acharjeei consuming electricity dishonestly by means of hooking from nearest lt network of WBSEDCL for his bricks farm at Chitra baro tar. Then we disconnect his hooking wire with hooking device ,seized the PVC wire 15 metre with hooking device along with one bulb and holder fitted with pvc wire and one PVE switch board .Bulb - 3 Nos Total-0.5 KW(approx).

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.05 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
