On the basis of said complaint at about 02.15 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sk. Brihaspati Ansari, and found that he is consuming electricity dishonestly by means of tapping by with bypassing meter for registering actual consumption against consumer id 242071807.

Total Load found approx 0.62 KW (fan-3 nos, TV-1 no, Bulb-3 nos)

Then we disconnect his permanent connection and seized the following articles.

1) Tapping point of service cable 1 meter(approx) along with pvc wire 5 mt..

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.35 pm. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
