Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Basant Orang, S/O- Santosh Orang of Village- Ranidih, P.O- Rajnagar P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 09-01-19 at about 07.25 PM I, Sri Swarn Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Basant Orang, S/O- Santosh Orang of Village- Ranidih, P.O- Rajnagar, P.S.- Kenda, Dist - Purulia and inspected his/her premises and found that he was using electricity dishonestly by direct hooking from WBSEDCL LTOH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Bulb 100 watt 1 NO
- 2) Bulb 60 watt 2 nos.
- 3) Fan 1 NO
- 4) TV 1 NO.

out of which we seized the following -

- 1) SL (Eight) mtr 2 Core Pre wire along with hooking derke.
- 2) one no 100 watt bulb.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 07.35PM on dated 09-01-19. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
