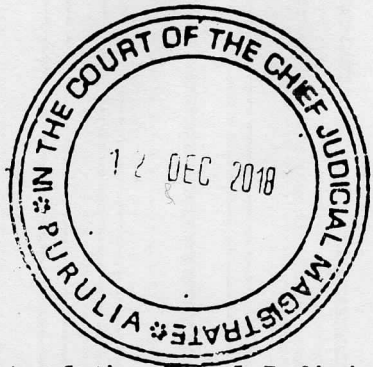

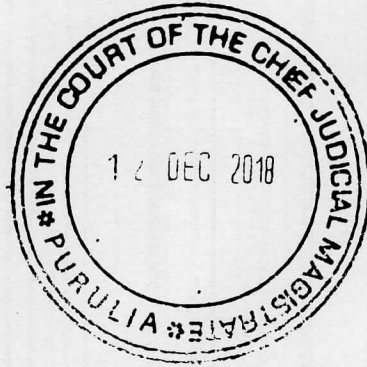

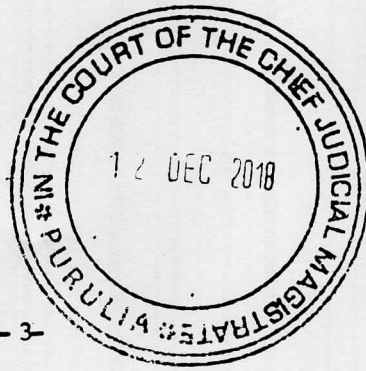
Occurance

on 12.08.2018 and at village Chandra under p.s. Kenda District Purulia.

The complainant above named beg to state as follows:-

1. That accused no.1 Subrata Mahato of village Panjanbera under p.s. Kenda came to house and they took away the son of the complainant namely Karna Mahato along with some other persons to Andrapradesh where they engaged Karna Mahato as a daily labourer.
2. That on 08.03.2016 my son Karna Mahato sustained injury on his head and all over body but they did not inform about his injury to the complainant.
3. They told the complainant on 12.03.2016 when they came to the house of the complainant with the dead body of said Karna Mahato that they admitted him at Guntur Hospital and on 10.3.2016 in life Hospital Gantur Hospital and on 10.03.2016 life Hospital Gantur discharge him and refer for higher Medical centre. The accused persons assured the complainant that they will handed over all the medical papers of deceased Karna Mahato to the complainant very soon and they will pay Rs,5,00,000/=(five lakh) to the complainant very soon as a compensation amount but they did not pay the said amount to me till today

lastly on 12.8.2018 complainant requested the accused persons to pay the said compensation but they denied the same and they also did not give the medical papers of deceased Karna Mahato to the complainant. The complainant requested them several times to pay the said compensation amount but they deffered the matter for the reason best known to them. The accused persons are/were fully responsible for the unnatural death of my said son. They have cheated the complainant. The complainant sent a notice upon the accused person through his Ld. Advocate, but after receiving the notice they intentionally avoid the complainant and their activities clearly shows. that they have cheated the complainant, The complainant reported the matter to the O/C Kenda p. s. but police did not take any steps against the accused persons and the complainant also reported the matter of the S.P. Purulia ,so the complainant have been compelled to file this complaint before your Honour for taking proper steps against the accused persons named above.

It is therefore prayed that your Honour may be graciously pleased to sent this petition of complaint to the O/C Kenda p. s. to treating the same as F.I.R and to investigate the same as provided u/s 156(3) Cr.P.C.
