Entered the premises of Radha Gobinda Kumar (Present User) Vill- Adardih, PS- Kotshila, Dist- Purulia. having consumer Id-242220286, Meter no 144278 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)/(B) & (C) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 02 nos.
2. Color T.V- 01 no.
3. Electric Fan - 01 no.
4. Tube Light- 01 no.

Out of which I seized the following.

1. One single phase energy meter & approx 2 ft. 2 core PVC cable.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 02.15 P.M on 02.01.2019. The accused person has committed an offence U/S 135(I)/(b) & (C) of the electricity act-2003 subsequently electricity (Amendment) act-2007.
