During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)/(B) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 06 nos.
2. Color T.V- 01 no.
3. Electric Fan - 03 no.
4. Tube Light- 03 no.

Out of which I seized the following.

1. Two core service cables fitted with tapping cable approx length 15 ft.
