Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that PariKshit - Mahato S/O- Magan ch Mahato of Village- Swigora, P.O- Jharbagarh, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07/01/2019 at about 7.45 pm, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 2) Santu Dhal, SAE, manbazar ccc

entered the premises of PariKshit Mahato, S/O- Magan ch. Mahato of Village- swigora, P.O- Jharbagarh, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDEL LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos of 200 Watts bulb
- 2) One nos of 100 Watts bulb
- 3) Three nos of 65 watts ceiling fans.

out of which we seized the following -

- 1) One no. 100 Watt bulb
- 2) 2 core pvc cable (3 metres) along with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 7.55 pm on dated 07/01/2019. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
