Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Haren Mallick (42) S/O- Lt. Anil Mallick of village Mazeradih, Mallick Para, PS-Santuri, District- Purulia with seizure of (1) 25 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (12.01.19) at 17:05 hrs while myself along with force were performing anticrime day mobile duty near Haridih More, received source information that one Haren Mallick (42) S/O- Lt. Anil Mallick of village Mazeradih, Mallick Para, PS-Santuri, District- Purulia has illegal stock & selling of liquor in a shop beside Subhash More under PS Neturia. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Subhash More for work out the information. At 17:25 hrs after reaching at Subhash More held raid in the shop of Haren Mallick (42) S/O- Lt. Anil Mallick of village Mazeradih, Mallick Para, PS-Santuri, District- Purulia which is situated beside Subhash More to Santuri pitch road at Mouza Bansboni under PS Neturia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Haren Mallick failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 25 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Haren Mallick (42) S/O- Lt. Anil Mallick of village Mazeradih, Mallick Para, PS-Santuri, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/1260 Santosh Soren and 2. C/470 Somnath Nag both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Haren Mallick (42) S/O- Lt. Anil Mallick of village Mazeradih, Mallick Para, PS-Santuri, District- Purulia under proper section of law.
