I do hereby lodge Complaint empowered by enabling
the IE Act 2003 duly amended on 2007 that to the effect
on (07-01-2019) SK Abajal Hosen s/o - SK Dalil of vill -
Nimdanga was enjoying electricity by means of direct
hooking from the nearest LTOH line of WBSEDCL, due
to this reason he has committed theft of electricity
vs - 135 (1) (a) of the Electricity Act 2003 amended on
2007.

On (07-01-2019) at about 16:20 Hrs I Sibdas Ball,
s/o Dipak Ball along with ① Goutirmoy Dass, Sr. SAE (E)
② Sri Kanai Sasmal, LM of Saltore CCC had been in
the village of Nimdanga for inspection of electric line
of WBSEDCL. During inspection it has been observed
that two nos hooking device with single core pvc cable
has been connected with low tension overhead line
of WBSEDCL and the other end of the pvc cable is
connected to the internal wiring of SK Abajal Hosen.
From the arrangement he was using electricity for the
equipments viz:- ① Electric Lamp - 02 nos (100 watt each).
② Electric fan - 02 nos (80 watt each). Total load found 0.36kw.

After inspecting the arrangement it has been cleared that Sh. Abajal Hosen s/o - Sh. Dalil was enjoying electricity dishonestly by drawing illegal hooking from the nearest LTOT line of WBSEDCL, i.e. 135(1)(a) detected.

From the above arrangement I seized the following as a token:

- ① Two nos Single Core PVC Cable with two nos hooking device of Route length twenty feet approx.
- ② One Electric Bulb with holder - 100 watt.

Seizure list was prepared at the site and the accused person refused to sign on it. The inspection team left the premises on 07/01/2019 at about 16:35 hrs.

The accused person has committed an offence u/s-135(1)(a) of the electricity Act 2003 duly amended on 2007.

You are requested to take cognizance of the Complaint and treat it as FIR and action may be taken as per rule.
