I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri DILIP BOURI (Present user) S/O- Late BARUN BOURI of Village- Anara, P.O- Anara, P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007. On dated 08.01.2019 at about 2:45pm I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSIEDCL along with,

Entered the premises of DILIP BOURI, S.O- Lt. BARUN BOURI of Village- Anara, P.O- Anara, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from incoming side of service cable by PVC wire.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) Fan => 2 NOS (2x80watt = 160watt)
2) Bulb => 5 NOS (500watt)

Out of which we seized the following:

- 1) Energy meter with tapping service cable (Meter No-L368802)

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 3:00 PM on dated 08.01.2019. The accused person has committed an offence U/S-135(i)(b) of the Electricity (Amendment) Act-2007.
