

The above named complainant beg to state :

- the accused no.=1 and their marriage was solemnised in the month of Falgun near about 13 years ago as per Hindu rites and comtoms previling in their community at the time of marriage father of the complainant gave a sum of Pupees Ten thousand, Two vories of Silver ornaments and Unitensils. After marriage the complainant had been to the house of accused no.=1 at village Jalika under P.S. purulia (M), lived there as husband and wifeand their wed lock and the complainant gave birth Two male child and one daughter and their age is 10, 7 & 5 years
- with the instigation of other accused persons, the accused no.-1 demanded a sum of Rupees Twenty thousand (20,000/-) to start a business. But the family members of the complainant did not fulfil their demand. Hearing the news the accused person's started ill-treatment torture both physical and mentally upon the complainant. They did not provide sufficient food, Medicine and clothes

to the complainant. The accued persons did not allowed the complainant in her bed room and the accused no. 1 assulted the complainant by fist and blow without any reason. And for the reason above the life of the complainant is the

- the accused persons was increasing day to day and on 12/07/2018 corresponding to 27th day of Ashar 1425 B.s. drove out the complainant after assulting the complainant and her minor son's and daughter from their house. There after the complainant and her minor son's and daughter any how mannaged and come to her father house at village Bhangra. The complainant reported the matter to her parents and other family members since than the complainant is in the house of her father with hope that the accused persons will realise their fault and fake false back to their house till now no good.
- 4) That the accused no.-1 as the husband of the complainant, accused no.-2 is the mother -in-law of the complainant and accused no.-3 is the sister-in-law of the complainant.

- 5) That on 14/08/2018 the father of the complainant and one villager namely Ram pada Paul took the complainant and her minor sons and daughter to her father—in—law house but the accused flately refused to take shelter then without fulfill the demand.
- That the complainant had been to the purulia (M) P.S. and informed the incident but police personel of Purulia (M) P.S. has not started any case their after the complainant informed the matter to S.P. Purulia but off no good.
- 7) That the accused persons have committed offence Under section 498(A)/34 I.p.C.
- 8) That the complainant is one poor and schedule caste woman and could not any capacity to bear the expences of the case \*\* for which the complainant seeks Justice.





It is therefore prayed before your Honour would be pleased to direct the officer in-charge of Purulia (M) P.S. for investigation of the case against the accused person by treating the complainant as F.I.R. as provided U/s. 156 (3) Cr.p. code.
