

On anatomizing the accessible PS records, I do hereby lodged a suo motto written complain in respect of the discovering of an unknown female corpse which was found at beside kacha road from Uchali village to Tata road under Purulia (M) PS, Dist -Purulia. The nub of the fact in a nutshell is that on 18/4/18 at 08.45 hrs I received telephonic tidings that an unknown female corpse was lying at above noted place. Subsequently, I directed SI Mithun Kr Sar the then Tamna OP in charge to work out the information. On getting in the spot, he acquainted that the corpse was of a female, age about 25 yrs putting on a light blue colour Churidar and payjamas and the corps was unknown. None of the neighbourhoods could identify the female dead body after espial of the corpse. Subsequently, I initiated a formal First Information Report of Unnatural Death U/S 174 of the Cr.P.C vide Purulia (M) PS UD Case no 07/18 dated 18/04/18 and forwarded to the Executive Magistrate and directed SI Mithun Kr Sar to hold surathal of the corpse. In pursuance of my extemporary order, he prepared the surathal report ensuring the dignity and honour of the female corpse in presence of the neighbourhood witness and lady constable of Purulia (M) PS. He took the photograph of the corpse. During the holding of the surathal report, apparently, he found blood on the right ear and left eye scratch injury on the neck. He sent the dead body to the Deben Mahato Sadar Hospital, Purulia Morgue to ascertain the actual time and cause of death of the female corpse. Subsequently, the photograph of the corpse was widely circulated to fix up the identity of the female corpse. In spite of the wide dissemination, after maintaining all formalities, the identification of the dead body could not be fixed up. Therewithal, the process of CIG publication was rehashed for identification of the female corpse but it also did not lead to any inference of identification till the date. Today (31/12/18) 13:25 hrs received the Post Mortem report of the unknown female dead body vide Purulia (M) PS UD Case no 07/18 dated 18/04/18, bearing the Post Mortem No 308 dated 19/04/18 and I perused the report meticulously and thoroughly and found that Dr. Amal Nath, Medical Officer, Medico Legal of Deben Mahato sadar Hospital, Purulia conducted the Post Mortem of the dead body. He opined, "The death due to Asphyxia due to strangulation, ante mortem and Homicidal in nature." The probable time was since death within 30 to 35 hrs before time of PM Examination. On going through the valuable opinion of the Medico Legal Expert, it could be ascertained that unknown miscreant/miscreants murdered the unknown female at anywhere with an intention and left behind the dead body at the supra noted spot for causing disappearance of the offence. Ergo, I initiated a specific case after filling up a formal FIR vide Purulia (M) PS Case No 273/18 dated 31/12/18 U/S 302/201/34 of the IPC and directed SI Tapan Tiwary In Charge Tamna OP to investigate the case accordingly.
