Dear Sir,

I regret to inform you that yesterday (30.12.2018) night at our Ramakrishna Mission Vidyapith, Purulia logs of three full-grown sandalwood trees – one planted in our Gurupally (Staff Quarters), the second one in our Dairy Farm and the other planted in our land on Kalyan Campus (opposite to our Vidyapith main campus) were surreptitiously cut and taken away by unknown miscreants/ miscreant. They attempted to take two more logs (one in the dairy complex and the other in our Ma Sarada Free Coaching Centre campus). That is evident from the saw-marks on them. It may kindly be noted that previously three times (once in 2010 and again on 28.01.2016 & 24.04.2016) a number of sandalwood trees were stolen. Some suspects, however, were later arrested after the 2010 incident.


May I request you to kindly look into the matter and do the needful please.
