In the above captioned subject, we would like to inform you that today 08.01.19 (Tuesday) late night some miscreants attempted to theft at our onsite ATM premises, located at ground floor of our Bank premises building at Sindri Chas More, P.O.- Sindri Chas More near Chopra Service Station (Petrol Pump) under Purulia (M) PS, Dist-Purulia.

On arriving at the Bank I found that lid of the ATM Cabinet was broken down and the ATM Cash Dispenser along with the display of the ATM machine was damaged partly. The miscreants attempted to cut the vault of the ATM with view to take away the cash inside the vault. They also damaged the UPS of the ATM as well as the wires for CCTV Camera, UPS, Alarm System & Light Connection.

On local enquiry it was found that the incident happened at late night and the miscreants failed to commit the crime due to interference of the Civic Volunteers who were performing duty near the Bank.

In this regard I request you kindly arrange to lodge a FIR in respect of the incident and for it's investigation.
