With one respect I would like to state that on 01.01.2019 at about 10:30 - 10: 35 P.M. when I along with star was friends namely Bijay Bissa S/O- Lt. Meghraj Bissa of Chabi Biri Dharmasala Gali, ward no. 15, Purulia Municipality, P.S.-Puurlia (T) and Rohit Bhakat S/O-Shyam sundar Bhakat of Jail Khana More, Purulia in my car a new Hyundai i20 bearing no. WB- 56-TC-0018, driven by me were starting to go towards Gosala More at Reny Road, a bike rider along with a co passenger riding a Yahama R15 bike, white coloured in a high speed coming from the other side in a high speed, riding in a rough and negligent way came and dashed at the right side of my car, middle portion. They fall down, I applied my car's break and stopped. We came out of the car and saw they were injured. Some of the local people came to the spot and helped us to pick up the injured persons into our car and take them to the hospital for treatment.

We took them to the Deben Mahato Sadar Hospital, Purulia for treatment and admitted them there. Some of the police officials came to the hospital and out of them one asked me to take my car to the Purulia Town Police Station, I did it accordingly. And there handed over the key of the car, my driving licence bearing no. WB-56F-3731, the car related papers like insurance, bills and other documents to the Police personal attached to your Police Station.

I and my friends sustained from mental shock and trauma so is late in lodging the information before you.

My vehicle got badly hampered from the right side due to such incident.

Thus I request your good self to lodge the information against the rider of the said motor cycle due to whose rough and negligent driving at a high speed this incident took place. It would have caused severe harm to us as well as them.

Later on when I went to meet with the injured persons at the hospital came to know from the Deben Mahato Sadar Hospital Authority that one of the injured succumbed to the injuries and the other injured person was referred to higher centre for further management.

Please take necessary action as per law.

Please do the needful by providing information on the procedure of getting my car back to my possession from your thana premises.

This is for your information and necessary interventions.

Please do the needful and oblige.
