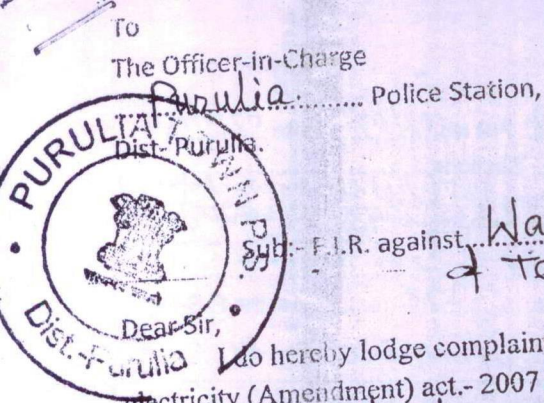

Entered the premises of Wasiuddin Khan (Present User) VIII Teachers Colony, S.G. Road, P.S. Purulia Dist- Purulia, having Consumer No. 242024617. Meter No. IPBB 29164 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in W.B.S.E.D.C.L. energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- i) Electric fan - 08 nos. ii) Freezer - 01 no. iii) Colour TV - 01 no. (iv) Water Pump - 01 no.
- v) LED Bulb - 08 nos. vi) Electric Geyser - 01 no. vii) Tube light - 4 nos.

Out of which I seized the following.

1. P.V.C 3 core cable alongwith bypassing arrangement - 06 ft (approx)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 4:22 Pm on 07/11/2019. The accused person has committed an offence U/S135(I)/(b) of the electricity (Amendment) act.- 2007.
