Sir,

In producing herewith the arrested accused person namely Suman @ Bura @ Sumanta Das (26 Yrs.) S/o Kalipada Das of Tantipara, Ward No 3, PS - Raghunathpur, Dist.- Purulia alongwith seized articles one improvised country made one shutter fire arms loaded with one round 8mm live ammunition to the fact that on 12.01.19 while I was engaged in case investigation on 12.01.19 at 20:45 hrs, received credible source information that one person being equipped with fire arms, moving around Raghunathpur Town area with ill motive. I also took descriptions of the person and his wearing apparels (Ash colour Sweeter and blue colour jeans). Accordingly I informed the matter to O/C Raghunathpur PS and as per his direction I left to work out the information. On way I briefed my accompanied staff about the descriptions of the suspect person and the mode of action to be done during detention. At 21:05 hrs. we reached near Natun Sayer, Raghunathpur and ambushed ourselves inside a nearby thicket leaving the Govt. vehicle 200 meters away from Natun Sayer, Raghunathpur. After few minutes, we saw that one person, wearing same apparels as noted above was moving the above place. Accordingly we came out and intercepted him disclosing our identity.

On being asked the person disclosed his name and address as Suman @ Bura @ Sumanta Das (26 Yrs.) S/o Kalipada Das of Tantipara, Ward No 3, PS - Raghunathpur, Dist.- Purulia. On being searched of him one improvised country made one shutter fire arms loaded with one round 8mm live ammunition could be recovered from the possession of the above noted accused person which was kept the right side of his waist under his full pant. On demand he failed to produce any valid document in respect of possession of arms and ammunition. He also confessed that he had procured the same to commit any crime at Raghunathpur Town area. Hence, I arrested him issuing arrest memo, informed ground of arrest and other guidelines regarding arrest. Then, I seized one improvised country made one shutter fire arms loaded with one round 8mm live ammunition under proper seizure list and proper leveling duly signed by the above noted accused person and police witnesses. No public witnesses are available at that time.

On return to PS, I lodge a complaint against Suman @ Bura @ Sumanta Das (26 Yrs.) S/o Kalipada Das of Tantipara, Ward No 3, PS - Raghunathpur, Dist.- Purulia with a prayer to start a specific case as per law.
