Sir,

In producing herewith one truck (12 Wheeler) bearing No. BR 17G/2246 loaded with stolen coal approx 20 (Twenty) Tons with proper seizure list. Fact of the case in brief is that on 04.01.19 myself along with C/464 Purna Chakraborty, C/84 Mahadeb Hembram and C/985 Laxman Ch. Majhi were on Evening Mobile Duty on Raghunathpur – Bankura road and received a source information that the above noted vehicle is coming loaded with coal from Santuri side towards Raghunathpur. After receiving this information, I informed the matter to O/C Raghunathpur PS and as per direction of O/C Raghunathpur we had been to Raghunathpur – Bankura road near Lohar Pul and placed Naka Checking with a view to intercept the said vehicle. At 20:45 hrs we found that one truck is coming from Santuri side. Seeing police party the driver of the said truck attempt to flee away with the truck but on being chased the driver stopped the truck on road and fled away towards open field. I searched the truck and found that about 20 (Twenty) Tons coal loaded in this truck and the key of the truck has been left away in the truck by the driver. We searched the surrounding area to find out the driver but failed to trace out him. No public witness was available there. It is reasonable to believe that driver and owner of the said truck collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains. Accordingly, I seized the said truck loaded with approx 20 (Twenty) Tons coal including sample approx 05 Kgs. sample under proper seizure list .

I therefore pray that kindly lodge an FIR against the driver and owner of the truck bearing No BR 17G/2246 as per law and arrange its investigation.
