Sir,

In producing herewith one accused person namely Rabi Bauri (55 Yrs.) S/o Late Kuran Bauri of Vill.- Ishradanga, PS – Raghunathpur, Dist.- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 28 (Twenty Eight) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 280/- (Two hundred eighty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 06.01.19 at about 19:05 hrs during my evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel beside on Raghunathpur – Santuri Road near at Ishradanga village. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/1325 Sunil Kr Mahato, C/853 Kiran Ch. Murmu and C/706 Asit Baran Pati rushed to the spot to work out the information. On arriving to the line hotel on Raghunathpur – Santuri Road near Ishradanga village, I apprehended the above noted person after a strong attempt and six customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Rabi Bauri (55 Yrs.) S/o Late Kuran Bauri of Vill.- Ishradanga, PS – Raghunathpur, Dist.- Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Rabi Bauri (55 Yrs.) S/o Late Kuran Bauri of Vill.- Ishradanga, PS – Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
