Sir,

In producing herewith one accused person namely Kartik Bauri (23 Yrs.) S/o Paltu Bauri of Chelliyama, Dharmasthan, PS – Raghunathpur, Dist.- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 24 (Twenty Four) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 220/- (Two hundred twenty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 06.01.19 at about 20:15 hrs during my 2ND evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel cum house beside on Raghunathpur – Chelliyama Road at Chelliyama. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/464 Purna Chakraborty, C/84 Mahadeb Hembram and NVF/1085 Pranab Mahanty rushed to the spot to work out the information. On arriving to the hotel cum house on Raghunathpur – Chelliyama Road at Chelliyama village, I apprehended the above noted person after a strong attempt and four customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Kartik Bauri (23 Yrs.) S/o Paltu Bauri of Chelliyama, Dharmasthan, PS – Raghunathpur, Dist.- Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Kartik Bauri (23 Yrs.) S/o Paltu Bauri of Chelliyama, Dharmasthan, PS – Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
