Sir,

I SI Anjan Kr. Biswas and along with force C/47 Rabindranath Basak and C/330 Banamali Soren while my patrolling duty that today on 08/01/19 at 06:05 hrs received a credible source information that a TATA ACE bearing registration No-WB81/0317 is coming from Raghunathpur side via Raghunathpur-Saltora road (SH-8) loaded with coal which has been procured by means of theft or any fraudulent means. Accordingly, I along with force (C/47 Rabindranath Basak and C/330 Banamali Soren) left to work out the said source information after obtaining kind permission from O/C Santuri PS. At Ledason Morh I along with force placed a Naka to apprehend that vehicle. At about 06:45 hrs we found that the above noted vehicle is coming from Raghunathpur side. Seeing Police party at Ledason morh the driver of the said vehicle flee away by stopping the vehicle on road. We chased to apprehend the driver but failed. After searching it could be ascertained that the said vehicle having registration No- WB81/0317 (04 Wheeler) is loaded with coal approx 01 (one) Ton. I think that the Owner of said vehicle (WB81/0317), driver of the vehicle(WB81/0317) and others collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. Under proper seizure list I seized the TATA ACE having its registration No- WB81/0317 loaded with coal approx 01 (one) Ton. Then I, sealed & labeled approx 01 (One) K.G. coal as sample coal. After that, I brought that seized vehicle loaded with coal at Santuri PS compound.

I therefore pray before you to lodge a specific case against accused Registered owner of the seized vehicle having its bearing No- WB81/0317, Driver of the seized vehicle bearing No- WB81/0317 and others under proper section of law.


