





③ Raban Musmu and his son has aggressive to attack in my house which is in the process of being construction with Axe, The Hammer, Ironbar etc. and destroyed the construction

The gang not only beatin the family members but also tried to violation of modesty of the female members of my family.

Before leave the spot they threatened to kill, if furthera attempt of construction is to be taken they are very dangerous in nature in this circumstances we are felling insecure. so I requested

your kind honour to take appropriate and immediet step in this regard.
