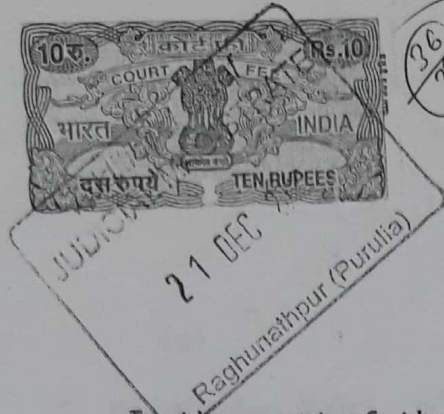

Most respectfully showeth :-

1. That the complainant prior to his marriage had
love affairs with Sm. Namita Bouri, D/o Sri Santosh

into holy marital tie according to Hindu rites and
customs and out of wed-lock they were blessed with
3 sons.

2. That it is pertinent to mention that the brother
of complainant's wife namely, Bijoy Bouri who figure as
accused No.1 was all along against his sister's marriage
with the complainant and that after such marriage accd.
Bijoy Bouri not only used to tease and hurl abusive
words upon the complainant off and on but also at
times accused No.1 used to come to the house of the
complainant and picked up quarrels and assaulted the
complainant and his wife Namita Bouri who figures as
witness No.2. The complainant took the matter lightly


and as such he did not lodge any complaint before any competent authority against the accd. No.1 aforesaid. It is pertinent to mention further that the accused No.1 subsequently got married with Sumitra Bouri who figure as witness No.2 and thereafter both the accused persons not only abused the complainant but also threatened the complainant in dire consequences at times.

3. That on 27/10/2018 at about 5.00 P.M. both the accused persons came to the front gate of the complainant's house and after that both of them hurled taunting as well as ~~abusive~~ ^{abusive} words to which the complainant protested whereupon both the accused persons criminally trespassed into the house of the complainant and after that accused Bijoy Bouri with the help of one thin Rod used in cart attempted to hit on the head of the complainant but the said attempt made on the neck of the complainant and as such the complainant fell down on the earth after a loud ^{groaning} cry. The witness No.2 witnessed such incident and practically she saved the complainant and that the witness Namita tried to remove the accused persons from their deadly clutches but accused Sumitra Bouri went on assaulting the complainant by fists, blows and kicks and at that time hearing such hue and cry the

other witness who figures as witness Nos. 2 and 4 came to the spot and saw the entire incident and at their intervention the complainant and his wife got saved and thereafter both the accused persons left the place with a threatening to implicate the complainant and his relatives in false cases. The complainant subsequently was taken to Hospital by witness No. 5 on the following day i.e. on 28/10/2018. It is pertinent to mention that as the complainant was feeling severe pain in head and was vomiting he could not reach the Hospital for treatment on 27/10/18. The complainant got treated at Hospital on 28/10/2018 as such and he also lodged F.I.R. before Santuri P.S. on 28/10/2018 to which the duty officer assured to take necessary action against the miscreants but to no effect and as such the complainant reported the matter before the Superintendent of Police on 19/11/18 but it is strange that a month elapsed nothing tangible has been effected from the side of Police till date. Hence, after compliance thereof the complainant has come before your honour's court with this complaint.

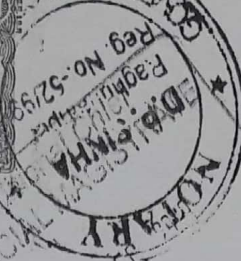
It is therefore prayed that the O/C, may kindly be directed to investigate the case u/s 156(3) Cr.P.C. treating this complaint as F.I.R.
