Sub: Prayer for lodging FIR against accd. (1) Bhaktu Majhi (30 yrs) S/O Chunarām Majhi of VII-Ushir, PS-Santaldih Dist-Purulia (S 46A (c) B.E. Act.

Sir,

In producing herewith arrested accused (1) Bhaktu Majhi (30 yrs) S/O Chunarām Majhi of VII-Ushir, PS-Santaldih Dist-Purulia along with seizure - list and seized items as described below, I beg to state that on 06.03.17 at about 01.15 hrs received a source information to the effect that the ID liquor "Tari" have been kept at Ushir village in the house of above noted accd. illegally with an object to sale. It refers Santaldih UC (BCW) GDE No- 62 dated- 06.03.17. Then myself along with force left for Ushir village to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the house of Bhaktu Majhi, VII - Ushir, P.S. Santaldih at about 02-15 hours. Seeing police some unknown persons in front of the house of Bhaktu Majhi fled away.

However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the ID liquor "Tari" for selling and he was the owner of the said house. However, I along with said accd. started a search inside the house of Bhaktu Majhi and found the following items in the said house.

- 1) 01 Plastic jar loaded approx 40(forty) liters "Tari" from the possession of above noted accd. Person.
- 01 (one) bottle of 600 ML taken, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing of the "Tari". He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 02:15 hrs and 03:05 hrs & took up one bottle - as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the ID liquor "Tari" illegally without any valid papers for the purpose of selling in his house has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 02:35 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused (1) Bhaktu Majhi (30 yrs) S/O Chunarām Majhi of VII-Ushir, PS-Santaldih Dist-Purulia.
