Subject: Report of Severe Physical Assault to on duty Civil Stick Security Guard of M/s. Panther Security Service namely Mr. Samanbhis Anari, S/O Late Nandubhis, age about (thirty two) 32 years, deployed at Gate No. 4 of STPS on the night of 25.03.2017 at about 23.45 hrs.

Dear Sir,

Enclosed letter of Sri Sanjib Kumar Biswas, Senior Executive (Security), STPS which is referred above, may kindly be perused. Sri Sanjib Kumar Biswas has reported that on the night of 25/26-03-2017 at about 23.45 hrs. one Civil Stick Security Guard namely Mr. Samanbhis Anari, S/O Late Nandubhis resident of Bellara, Santalidih, Purulia, age about 32 years while performing his duty at Gate No. 4 of STPS Township near Bellara, some 10 to 12 unknown individuals armed with iron rod, lathi etc attacked him inside the Security Post and started assaulting him. He sustained bleeding & swelling on the eye and nose and other parts of the body & fell down on the ground. On hearing noise and barking of dogs, Sri Nandubhis Pandey, Civil Stick Security Guard of M/s. Panther Security Service of the neighboring post, informed Security Supervisor namely Sri Ganesh Prasad. After getting information Sri Ganesh Prasad with another Civil Stick Security Guard Sr. Goushish Mishra the spot and shifted Mr. Samanbhis Anari at STPS Medical Unit for treatment.

After being released, Sri Sanjib Kumar Biswas, Senior Executive (Security), STPS alongwith Sri Chandra Halderjan, Security Inspector, STPS, Sri Tapas Ghoshal, Assistant Security Inspector, STPS, Sri Pavan Sab, Assistant Security Inspector, STPS also visited STPS Medical Unit and found the injured guard in serious condition near Gate, west, Town. Medical Officer of STPS Medical Unit referred him to Purulia Sadar Hospital, respecting factors and internal knowledge.

It is to be noted here that if the misdeed shown again, injured may identify some there as the gate was illuminated as mentioned by Sri Sanjib Kumar Biswas.

In view of the above, you are requested to kindly take cognizance of this letter as FIR and further necessary course of action as per law.
