In producing here with one arrested accd namely Jagdish Hela @ Modha (40 Yrs.) S/O Parma Hela of Lower Jhariadih, Adra PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 21 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs. - 97/-
- 3) Ten pieces of plastic glass.

I ASI Dulal Singh Sardar Adra P.S. do hereby lodged a complaint against accd. namely Jagdish Hela @ Modha (40 Yrs.) S/O Parma Hela of Lower Jhariadih, Adra PS- Adra Dist- Purulia to the effect that on 13.05.17 at about 14:15 hrs in course of my day mobile duty I received a telephonic information from a reliable source that one Jagdish Hela @ Modha (40 Yrs.) S/O Parma Hela of Lower Jhariadih, Adra PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/B62Ujal Rajak & HG/1438 Suchand Bankey rushed to the spot for raid by Govt. vehicle. At about 14:45 hrs. myself along with force reached at Lower Jhariadih, Adra and hood raid in the Jhapri (Near SBI Bank, Lower Jhariadih) of Jagdish Hela @ Modha (40 Yrs.) S/O Parma Hela found that said Jagdish Hela @ Modha liquor at his own Jhapri and seeing the police party some person fled away and said Jagdish Hela @ Modha to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Jagdish Hela @ Modha (40 Yrs.) S/O Parma Hela of Lower Jhariadih, Adra PS- Adra Dist- Purulia and arrange for its investigation.
