
In producing here with one arrested accl. namely Parun Bouri (44 Yrs.) S/O Lt. Akal Bouri of Palashkola, Near Bara Kali, Adra PS- Adra Dist- Purulia along with following seized articles viz:-

- 1) 19 bottles (in sealed condition) 861, KIRISH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs.- 88/-
- 3) Eight pieces of plastic glass.

I SI Supratic Mandal of Adra P.S. do here by lodged a complaint against accl. namely Parun Bouri (44 Yrs.) S/O Lt. Akal Bouri of Palashkola, Near Bara Kali, Adra PS- Adra Dist- Purulia to the effect that on 21.05.17 at about 17:45 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Parun Bouri (44 Yrs.) S/O Lt. Akal Bouri of Palashkola, Near Bara Kali, Adra PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/124 Asjit Khan & JC/219 Desaru Hanari rushed to the spot for real by Govt. vehicle. At about 18:15 hrs. myself along with force reached at Palashkola, Adra and hold rent in the Pan Stall (Near Bara Kali Mandir) of Parun Bouri (44 Yrs.) S/O Lt. Akal Bouri found that said Parun Bouri figure at his own Pan Stall and seeing the police party some person fled away and said Parun Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid license or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So I arrested the above mentioned accused person inferring the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accl. person and available witnesses.

Bees I there for pray that a specific case may kindly be started against arrested accl. Parun Bouri (44 Yrs.) S/O Lt. Akal Bouri of Palashkola, Near Bara Kali, Adra PS- Adra Dist- Purulia and arrange for its investigation.
