Sl no 5.4.1 of 198 - today went Panchayat ground Raghupati, P. -
Raghupati 1st Rivaldi who was arrested from the P.O. in connection
with the name of ~~and~~ French set up at the end of 198 - Government
under Area PS and several persons & arrested by P.O. Police
and 1st Rivaldi set up French set ~~and~~ Rivaldi set 1/10
arrested all are of 1st Rivaldi, Government P.O. Area 1st Rivaldi.
I would like to take note that today at 10-20 hrs
at 19-35 hrs received a telephone information from the inmate
that Raghupati set, to escape along with about 200 inmates
and nearby Area Conflict & French set ~~and~~ Rivaldi set (8) another
set of Government in name of Government set at 1st Government
alleging that they are 'witch' and there is every possibility that
anybody of other persons if they are not released immediately
then I need the information in 4-5 hrs will have

At 10-20 hrs he arrived at the house of Government

At 10:25 AM we arrived at the house of Josephine
Porch Mat at 112 Grandlawn. After arriving there I visited
out about 300 feet behind house and found a female of Grandlawn
Porch Mat, a black woman, wearing a dress, surrounded by some
of Parrot Mat, a black woman, (Josephine Mat's) wife, & another in law
of Josephine Mat. There is no post office now. After enough
information I will be able to go to front of the house of Porch
Mat. I noticed out a female child which was appalled to
see dead man lying at veranda of the said house. I also
noticed out a aged woman and aged person were confined
in the said house. Being asked they disclosed their particulars
as ① Parrot Mat & ② 125 Mat ③ 126 Mat ④ Porch
Mat ⑤ Parrot Mat wif Parrot Mat ⑥ Lookout Mat ⑦ 126
and 125 Mat Grandlawn. It seems the police party has
confined persons thought self from of as saying - A negro
man was seen near their house about 10 PM on the
situation also justified their statement when talked with
Josephine Mat and his family members. They stated that
a negro who was going away for 2 days came back from
the police I am afraid of being shot down now. Now 125 Mat
was present. I think my soul beat the bounds in gathering
but they didn't pay any heed to my words, however they
became violent.

At about 13:35 hrs no improvement reached
from lower fastest head position by (distal toes) moving
leg - 14519 TH 7/21 no improvement from 13 also carried
leg forward moving to 14519 TH 7/21. Right hand down 1/2 of
the body (cont.) and also rotated so leg held perpendicular to
also leg reached at the foot at end time. At about 13:35
hrs. P.D.

Smt. Kolewadi Kora, DMC Executive Magistrate attached with the office of SDO, Raghunathpur and Dr. Premangshu Bhattacharya of Babugram PHC came to the spot. The Dr. Premangshu Bhattacharya checked Riga's vital on the spot and declared her dead. But as the reason of death is not known to him he advised us to conduct PM over the dead body. The Magistrate also tried his best to convince the agitated people to release the confined persons safely so as to hand over dead body for PM examination.

Suddenly at about 14:15 hrs the mob became furious and rushed to the home of Parrot Patel and went to assault ① Parrot Patel ② Mitthi Patel and ③ Lakhibhai Patel in front of Police. Finding no other alternatives we the 112 of these 03 aged persons we pushed the mob to a safe distance from the said house with the help of lady police also pushed back the female mob to a safe distance. Then somehow we managed to rescue 03 aged confined persons and to lift the body of Riga Patel.

Then suddenly the Mob without any provocation from outside became furious and started to pelting stones & wound no. As a result I myself ASI Devdas Kora, 7/c 1079 Divisional Inspector of DAP Burnali and 7/c 218 Saranika 605 0405 and 05 105 Parole Tawari of EF Line Raghunathpur received several types of injuries on their persons. They also damaged police vehicle bearing Registration NO - WTB 19TH 4431 and WTB 560 8992 (Bolero).

Then finding no other alternative I arrested 04 female members with the help of HC and 03 male members from the spot as noted above. DHC took active part in assaulting Police and Ransacking the govt. vehicle.

As such the arrested persons along with 300 (three hundred) others including nearby villagers (forming unlawful assembly being armed with bricks, stone, bamboo stick went to hit 03 aged persons and restrained the Police in performing their duty by assaulting Police carrying

Their injuries on their persons and damaged the
govt vehicle. They are liable for prosecution/s
143/186 / 342 / 353 / 332 / 323 / 325 / 307 IPC & 03 PDPP Act
The arrested 04 female and withheld names were kept at
Raghunathpur women PS for under lady police guard.

Therefore I am registering this
Case S/o Mota by vide Adra PS case No - 50/17 dt
23/5/17 b/s 143/186 / 342 / 353 / 332 / 323 / 325 / 307 IPC &
03 PDPP Act. against the arrested said persons
namely - ① Mala Mal(2) b/s Tarmu Mal ② Mala Mal
(30) w/o Marmu Mal ③ Jhabori Mal(52) b/o Lt Khoru Mal
④ Chapale Mal (55) w/o Sundermal all are of Vill -
Goraindanga, PS - Adra, ⑤ Rabit Bonni () b/o Shyamal
Bonni ⑥ Sh. Brij Singh SK NTR ⑦ SK Raju b/o SK Akash
all are of Fronting School Banching ground, Raghunathpur, PS -
Raghunathpur and 300 others of Goraindanga,
Barabazar, Kamaldanga villages.
