Englewood 2132 Riverside who was arrested from the PO is, Coorwood  
- 1/2 of an hour of search but on 1 1/2 the rest of an hour  
under other PS and "resistant persons" & search but on 11 3/4  
- 1/2 @ 11 1/2 @ 11 3/4 @ 11 5/8 @ 11 7/8 @ 11 9/8  
children all were PS - Lodging, Coorwood, 7-8 also 3 1/2 hours

I could have to state here that during 11-22-1978  
at 09:35hrs received a telephonic information from the man  
called that Rajgopal Mal, & family along with about 300-400  
and many other confined @ Paroch Mal @ within Mal @ Lakshmi  
Mal @ Sundaranga in home of <sup>Englewood</sup> Mal at 11-22-1978  
alleging that they are 'witch' and there is every possibility of  
lynching of these persons if they are not released immediately  
before. Then I need the information - 420 800- the above  
PS 400 10 - 755 # 240712 I also inform the matter to Supervisor  
and at 09:05 hrs I myself along with force left for Englewood  
to look into the matter with other PS 400 10 - 755 # 240712 and  
NO - 100/10 also informed P.D. Englewood I met telephone to  
reported that to be present there to convince the people that  
the confined persons may be released.

At 10:25 hrs we arrived at the home of <sup>Englewood</sup>  
Paroch Mal at 112 Coorwood. After arriving there I visited  
about 300 agitated males and female of Coorwood  
Paradigan. Sundaranga, Lakshmi, Rajgopal Mal, wife & mother-in-law  
of Rajgopal Mal were in the front part. After thorough  
observation I could be able to go in front of the home of Paroch  
Mal. I noticed that a female child which was appeared to  
be dead was lying at veranda of the said home. I also  
noticed that 02, aged woman and aged person were confined  
in the said house, being asked they disclosed their particulars  
as @ Paroch Mal on 11 3/4 Mal @ within Mal use Paroch  
Mal @ within Mal @ Paroch Mal @ Lakshmi Mal use Paroch  
Mal all are of Coorwood, Pa. also, seeing the police party the  
confined persons thought left from @ saying - I know  
- that was about 100-150 for 100-150 @ 100-150 @ 100-150  
situation also justified their statement. Then talked with  
Rajgopal Mal and his family members they said that  
I should order the police party to go to the house  
for 100-150 @ 100-150 @ 100-150 @ 100-150 @ 100-150  
but they were paying my hand to my words, however they  
became violent.

At about 13:35 hrs the enforcement reached  
there from District Head Quarter by District (Br) name  
No - 101974/1631 reinforcement from 10 also arrived  
by before midnight. UNCL 1978. Rajgopal Mal PS of  
of Lady Court line also I tried to say Mobile phone party and  
also they reached at the spot at that time. At about 13:35  
hrs.

Smt Koleswari Kora, DM KDC, Executive Magistrate attached with the office of SDO, Raghunathpur and Dr. Premangshu Das of Bahngam PHC came to the spot. The Dr. Premangshu Das checked Riya Mal on the spot and declared her dead. But as the reason of death is not known to him He advised us to conduct PM over the dead body. The Magistrate also tried her best to Convince the agitated people to release the confined persons safely so as to hand over the dead body for PM examination.

Suddenly at about 14:15hrs the mob became furious and rushed to the house of Parosh Mal and went to assault ① Parosh Mal ② Mithila Mal and ③ Lakhbirri Mal in front of Police. Finding no other alternative to save the life of these 03 aged persons we pushed the mob to a safe distance from the said house with the help of lady police also pushed back the female mob to a safe distance. Then somehow we managed to rescue 03 aged confined persons and to lift the body of Riya Mal.

Then suddenly the Mob without any provocation from outside became furious and started to pelting stones to wound us. As a result I myself ASI Devidas Kaur, J/C 1079 Dwaru Khatas of DAP Imbula and J/C 218 Sasanka Das of Asants and of 105 Parshu Tawari of EF Line Raghunathpur received several types of injuries on their persons. They also damaged police vehicle bearing Registration NO - WTD 197H - 9831 and WTS 60 8992 (Biloro)

Then finding no other alternative I arrested 04 female members with the help of J/C and 03 Male Members from the spot as noted above. We took active part in surrounding Police and Ransacking the govt. vehicle.

As such the arrested persons along with 300 (three hundred) others including nearby villages forming unlawful assembly being armed with bricks, Stone, Bamboo stick went to with 03 aged persons and restrained the Police in performing govt. duty by assaulting Police causing

their injuries on their persons and damaged the  
 Govt Vehicle. They are liable for prosecution/s  
 143/186/342/353/332/323/325/307 IPC k. 03 PDPP Act  
 The arrested female aed witholep names were kept at  
 Rajhmadpur women PS, under Lady police guards,

Therefore I am registering this  
 Case Snd Moto by vide Adra PS case no- 50/17 dt  
 23/5/17 by 143/186/342/353/332/323/325/307 IPC k  
 03 PDPP Act. against the arrested aed persons  
 namely - ① Mela Mal (30) w/o Tarnu Mal ② Mela Mal  
 (30) w/o Mannu Mal ③ Jhabiri Mal (50) w/o Lt Khornu Mal  
 ④ Chapala Mal (55) w/o Sudorshan Mal all are of vill -  
 Goswaidanga, P. Adra, ⑤ Rohit Borri ( ) S/o Shyamal  
 Borri. ⑥ SK Pooj S/o Lt SK Nror ⑦ SK Raju S/o SK Akal  
 all are of Evening School Teaching ground, Rajhmadpur, PS -  
 Barabagan. Kamaldanga villages,  
 and 300 others of Goswaidanga,

SI Insanta Patrak will investigate the  
 case.
