Sub-Prayer for start a specific case against 1) Sumoyjit Goswami, via-Gouranga Goswami of Dalmi-Nadiba, PS-Purulia(T),Dist-Purulia, 2) Rabi Dey, via-Ujjwal Dey of Dalmi-Nadiba, PS-Purulia(T),Dist-Purulia

I PBI Sanjay Diger of Ansha PS Dist-Purulia do hereby lodge the complaint against two accused persons namely 1) Sumoyjit Goswami, via-Gouranga Goswami of Dalmi-Nadiba, PS-Purulia(T),Dist-Purulia, 2) Rabi Dey, via-Ujjwal Dey of Dalmi-Nadiba, PS-Purulia(T),Dist-Purulia, I would like to note here that on 22.05.17 I along with force were at Kourang Jungle right side of the pitch road of Purulia -Tara High Road. Our vehicle having registration no- WBMM1111 was parked in front of the check post room usually detached from pitch road and two SAP constables stood alone and driver of vehicle was standing on the further ground back side of the vehicle and engaged in conversation. I was standing on the left side of vehicle. Suddenly one motor cycle having registration no- WBMAE 7726 coming from Balarampur side with heavy speed dashed on the back side of one constable (1) Anup Bagti. As a result said constable got dashed on the back side of our vehicle and the driver and co-rider with said motor cycle skidded on the pitch road. Our constable got severe injury on his right leg and right hand. I found the driver of motor cycle that he also got injury on his person and co-rider got slight injury on his person. Arms & ammunition, magazine were watered on the ground. I asked the driver his name & address but he could not able to speak. I also asked co-rider about their name & address and he fractured their identity as told above. When I observed thoroughly the motor cycle driver and co-rider I found that both were unable to stand rightly. Alcoholic smells had come from their mouth. The driver of motor cycle was found that he was not in a position to drive motor cycle properly. I asked the driver and co-rider to produce driving license but they could not produce any DL, and also they don't have any driving license. It is fully clear to us that both the driver and co-rider had full intention to dash our force and to kill them. Speed of motor cycle was too high and driver had no control upon his motor cycle and intentionally dashed one constable who was standing far away from pitch road. Before going to Tadar Hospital for treatment I along with force searched the place properly with the help of road light I found & seized the offending motor cycle having registration No- WBMAE 7726 in damaged condition, seized one rifle INSAS, three INSAS magazine and also seized hundred round INSAS ammunition (36 nos) where 26 were found partially burnt due to dash from the side of pitch road at Kourang Jungle to get proper seizure list. Then I picked up the three injured persons from our vehicle and went to Tadar Hospital and they were treated at hospital. The injured constable was admitted at Tadar Hospital and I made arrangement and was sent to Durgapuri Narayani Hospital for better treatment. The motor cycle driver was referred to Bahara for better treatment and co-rider was at Tadar Hospital for treatment.

Under the above facts and circumstance I pray before your kind honour that a specific case may kindly be started against the above named two accused persons under proper section of Law and arrange for the investigation.
