Sub: - Prayer for starting a specific case against namely Badu Majhi S/O Banerwar Majhi of Vill Dhadkidi, PS- Arsha, Dist- Purulia.

Sir,

In producing here with one accused person Badu Majhi S/O Banerwar Majhi of Vill Dhadkidi, PS- Arsha, Dist- Purulia, under arrest and the following seized articles under seizure list enclosed here with.

- (1) 25(twenty Five) sealed plastic bottles (CS) containing 600ml each and labeled with DIL KHUSH
- (2) 09(Nine) sealed plastic bottles (CS) containing 600 ml each and labeled with DILSE.
- (3) Cash Rs- 205/- (Two hundred five) only.
- (4) One yellow nylon bag.
- (5) One white big polythin bag.

I do here by lodge this complaint regarding that today 25.05.17 at about 16:35 during my evening mobile duty receive source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in front of his house at Dhadkidi village under Arsha PS, Dist- Purulia. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/-442 Subrata Bera and C/-984 Krishna Prasad Hembram both of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot I apprehended the above noted person after strong attempted and one customer seen the police party managed to escape. On closed interrogation that apprehended person had disclosed his name and address noted above. I asked him to produced any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized on those noted after preparing proper seizure and labeled the seizure article duly signed by accompanying party in the seizure list and labeled. After this I arrested the accused namely Badu Majhi S/O Banerwar Majhi of Vill Dhadkidi, PS- Arsha, Dist- Purulia after preparing proper memo of arrest.

Under the above fact and circumstance I pray before you that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
