That the complainant being illiterate lady believing the version of the accused became ready on 09/08/2016 corresponding to 24th Shukla 1423 B.S. the accused person no. 1 to 4 called the complainant and brought her to registry office ^{Purnia} by vehicle they called Honshar Coral & Dhiren Mahato brought with them to Purnia registry Office.

4. That the accused no. 1 to 6 were conspiring with accused No. 7 and they made prepared deed to which on direction of accused complainant put her signature on , that document leaving as partition deed .

5. That in the first week of January 2017 the accused person no. 1 to 4 claimed the B.S. Plot No. 2090 and 2091 of Houza Balidh , 6 Goomals as their own dis-avowing that they here nobody purchased the same. The complainant became as-to-
- rashed on 09/08/2016 by a sale deed executed by complainant.

6. That the complainant searched registry Office Purnia and she came to know that the deed in which the complainant signed was a sale deed not a partition deed with respect to sale of B.S. Plot No. 2090 & 2091 to which Dhiren Mahato and Honshar Coral have been made as witnesses that the complainant never sold the B.S. Plot No. 2090 & 2091
