The Complainant begs to state

- 1... That the complainant is a residence of Village Kuda P.O. Kura, P.S. Baghmundi, District Purulia as well as the accused persons all residents of Village Antar-Kuda, P.O. Dhendih, P.S. Baghmundi, District Purulia.
- 2.. That on 4.3.17, one ~~Budheswar~~ Budheswar Singh Sarda alias Lodha of Village Kuda-Antar invited the complainant and others to attend the dinner party on the occasion of daughter's marriage Budheswar Singh Sarda @ Lodha. Accordingly the complainant and others attended the marriage party on 4.3.17, at about 6.30 P.M.
- 3... That while the complainant and others were taking dinner at about 7.00 A.M., a plastic glass with water was slipped down from the dinner table due to accident while the parties were serving food. The water fell on the part of Sri Biswajit Mahato S/o Niranjan Mahato of Dhanudih P.S. Baghmundi. There was a hot talk between the complainant and Biswajit

Whatso .The complainant took mercy due to sudden fall of water and there was no negligence of ill motive on the part of the complainant.

4.. That Misrajit Mahato threatened the complainant with dire consequences within that meantime all on a sudden the accused persons namely (1) Grikishna Singh Sardar (2) Maharaj Singh Sardar and Benkim Singh Sardar attached the complainant while the complainant were outside the house of Badheswar Singh Sardar with lathi and iron rod and assaulted the complainant on the various part of the body and tried to assault the complainant on his head with an intent to hurt grievously and/or attempt to murder but some visitors on seeing the position of assault rescued the complainant from the hands of accused person. The complainant ~~XXXXX~~ Ganesha Murmu is a Schedule caste community .In an open place in Misrajit Mahato abused the complainant

5...That due to late hours and there was no communication of buses etc. and approach the matter and due to fear the complainant failed to approach the matter to the P.S. on that night but on 5.3.17. the complainant went to Baghmundi P.S. informed the matter to the duty officer who noted the same on a paper and sent the complainant to Nathardih S.P. H.C. the attending doctor examined the complainant.

6...That the complainant being a schedule caste and Biswajit Mahato is an influential man in the locality the police officer of Biswajit Baghmundi knowing the same did not lodge any complain because the accused Biswajit Mahato committed an offence punishable ~~and~~ U/s 3(1)(a) of S.C./S.T. Act and the police officer has no power to investigate the case and unable to help the said Biswajit Mahato. That the ~~accused~~ accused persons are very dangerous in nature

That the complainant thought that police will take steps but when the complainant came to learn that no case has started hence the complainant is filing the instant case before the Ld. Court.
