The Complainant begs to state

1...That the complainant is a resident of Village
Kurda P.O. Shikri, P.S. Baghundi, District Purulia as well
as the accused persons all residents of Village Antash-
Kurda ,P.O. Shindeeth, P.S. Baghundi, District Purulia.

2..That on 4.3.17, one ~~Budhswar~~ Budhswar Singh Sardar
alias Lodha of Village Kurda-Jambari invited the
complainant and others to attend the dinner party on the
occasion of daughter's marriage Budhswar Singh Sardar
@ Lodha .Accordingly the complainant and others attended
the marriage party on 4.3.17,at about 6.30 p.m.

3...That while the complainant and others were taking
dinner at about 7.00 p.m., a plastic glass with water was
knocked down from the dinner table due to accident while
the parties were serving food .The water fallen
on the pant of Sri Bismajit Bhakta s/o Nitranjan Bhakta of
Dhanudih P.S. Baghundi, There was a hot talk between the
complainant and Bismajit



Mohsto .The complainant took water due to sudden fall of water and there was no negligence of immature on the part of the complainant.

4.. That Mawajit Mohsto threatened the complainant with dire consequences with that meantime all on a sudden the accused persons namely (i)Gurkishan Singh Sardar (ii) Balazir Singh Sardar and Binkin Singh Sardar attacked the complainant while the complainant were outside the house of Dadheesur Singh Sardar with lathi and iron rod and assaulted the complainant on the various part of the body and tried to assault the complainant for his head with an intent to hurt previously and/or attempt to murder but some visitors on seeing the position of assault rescued the complainant from the hands of accused person. The complainant soner Dushan Birmu is a Schedule caste community .In an open place in a Mawajit Mohsto stated the complainant

"ਅਸੇ ਬਿਕੁਨੀ ਸਿਰੀ ਦੇ ਰਾਵ ਭਾਵੀ ਜੀ ਬ੍ਰਾਹਮਣ ਰਾਵ ਤੁਹਾਡੇ ਵਿਚ ਪੂਰੀ ਰੱਖੀ ਗਈ ਹੈ ਕਿਵੇਂ ?"

The complainant lost his prestige on the said day in marriage ceremony party.

- 5...That due to late hours and there was no communication of buses etc, and approach the matter and due to fact the complainant failed to approach the matter to I.C.I.P.J.on that night but on 5.5.
17.the complainant went to Baghundi P.S.informed the matter to the duty officer who noted the same on a paper and sent the complaint to Rathnadeep S.P.N.C.the attending doctor examined the complainant.
- 6...That the complainant being a schedule caste and Biswajit Mahato is an influential man in the locality the police officer of Birnagar Baghundi knowing the same did not lodge any complain because the accused Biswajit Bhuiya committed an offence punishable u/s 3(1)(v) of C.P./S.T. Act and the police officer has no power to investigate the case and unable to help the said Biswajit Mahato.
That the ~~complainant~~ accused persons are very dangerous in nature
That the complainant that thought that police will take steps but when the complainant came to learn that no case has started hence the complainant is filing the instant case before the I.Court.
