Sect. Prayer for Judge specific case under proper section of law.

Sir,

In producing here with one seized Truck bearing registration number 030986-A121 loaded with different type and size and length of logs having different radius which were covered with a yellowish colored canvas under the proper seizure list, I beg to inform that today on 11.05.17 at 20:42 hrs got a tip off that a truck loaded with wood was going towards Shabda along Balasangpur Shabda road near the fort in GDR route GDR No. 528 Dist. 11-5-17. On getting the tip I along with my name 6-551 Bhuma Karmakar C/248 Ganesh Singh Santra left the PS side GDR No. 528, Dt 11.05.17 and C.C. No. 2226-17, Dist 11.05.17 to verify the information and on chasing I arrived at Assambong area under Baghmundi Range under Baghmundi PS., Dist - Purulia and found that above named truck loaded with wooden logs. But owing the police party the truck tried to flee away by over speeding. Accordingly we chased the truck and tried to stop him but the driver of said vehicle fled away from the spot. I searched the truck carefully and thoroughly but no documents found in respect of said truck as well as in respect of logs. I found the truck loaded with different type and size and length of logs having different radius. These Logs were covered with a yellowish colored canvas. Thus I seized the all materials in presence of witness witness under proper section law. In this circumstances there is sufficient reasons to believe that the said truck driver and the owner of the vehicle and others dishonestly acquiring the said stolen property and among each other in possession of stolen property and committing a clandestine business of the stolen forest wooden logs for hauling up Govt. property after forming up a criminal conspiracy for the purpose of wrongful gain through unconstitutional channel being violated the existing govt. order and showing threats towards the govt. during the night hours. I seized the Truck bearing Reg. no. 030986-A121 loaded with wooden logs under proper seizure list in presence of witness. As the driver of the truck bearing Reg. no. 030986-A121 and the owner of the said truck and the owner of said wood and the others committed offence L.S.-374-A(142)-A(4) CDR 1988 IPC and read with section 11 of West Bengal Forest Produce Transit Rules 1934. So a specific case may kindly be started against the driver of the truck bearing no. 030986-A121 and the owner of the said truck and wood and others and arraign for its investigation.
